Abroad, she has served as Head Economic and Commercial Counsellor of the Spanish Embassy in Colombia (2015-2020).

Her education extends further, with courses related to new tendencies in management of Public Affairs (Oxford University), technology and entrepreneurship (MIT) and team leadership (ESADE).
