All tenders must be submitted in US dollars excluding VAT or other taxes (taxes must be clearly described and separated).

BIDDING SPECIFICATIONS GOVERNING THIS TENDER SECTION A- GENERAL TERMS AND CONDITIONS

FIRST- Object

The object of this Tender is the selection of a Dressing Contractor who shall be awarded the execution of the <u>construction</u>, <u>assembly</u>, <u>maintenance and dismantling works</u> concerning the Pavilions of Spain at the following 2025 trade fairs and the purpose of the same is to achieve the best ratio between price and quality, wherefore ICEX is entitled to award the Tender to that Dressing Company which, at its sole judgement and pursuant to the offer submitted, provides the best terms:

If the trade fair organization decides to move the date of the show to a new date in 2025, postpone its celebration to 2026, or even cancel 2025 edition so that the show would be held in 2026, it will be understood that the established agreement between the successful Awardee of the tender and ICEX will be valid for the decoration of the Pavilion of Spain at ARAB HEALTH and MEDLAB MIDDLE EAST on those new dates. The new date of the fair will not affect contract extensions.

Consequently, after signing the agreement, the contractor will not start any production work until ICEX gives the appropriate instructions once the definitive fair dates have been set. These instructions will be given sufficiently in advance so that all the works can be accomplished.

SECOND. - Award Procedure

The selection of the awardee company of this Tender shall be conducted, pursuant to the internal regulations of ICEX, and following the application of objective criteria which are listed here below, based on the weighted values assigned to each of them.



The proposals that do not reach at least 50% of points in sections C3- C7. will be automatically excluded.

Tiebreaker Criteria.

In the event of a tie in the score obtained by two or more bidders, it will be resolved by applying the social criteria indicated below, in order and referring to the end of the proposal submission period. The supporting documentation of the tiebreaker criteria referred to in this clause will be provided by the bidders at the time the tie occurs, and not beforehand.

- Greater percentage of workers with disabilities or in a situation of social exclusion in the workforce of each of the companies, prioritizing in case of equality, the greater number of permanent workers with disabilities in the workforce, or the greater number of workers included in workforce.
- Lower percentage of temporary contracts in the workforce of each of the companies.
- Greater percentage of women employed in the workforce of each of the companies.
- The tie if the application of the previous criteria had not given rise to a tiebreaker.

ICEX reserves the right to collect information on any incomplete aspects or questions that may arise from the bids submitted by the participating companies. Participating companies must correct the defects by the deadline indicated in each case.

Every Company taking part in the tender shall receive appropriate notice on whether ICEX has decided to award them the Contract or otherwise.

ICEX may consider that no bidders qualify for the award of the tender if following the bids and documents submitted these do not comply with minimum requirements like solvency of the Contractor, the technical project, its suitability or the prices quoted.

ICEX reserves the right to revoke the award at any time if the winning bidder fails to fulfil any of the requirements in the Call for Bids and the General Terms and Conditions governing the tender.

The bidder with the highest score will be informed of the award as soon as possible.

THIRD. - Award sum

The price offered by the bidders shall include, among others, all expenses even those regarding fluctuations in exchange rates and cannot be modified during the period of the agreement and, if applicable, its extensions, unless express Contract thereon by the Parties.

The price tendered by the bidding company for net surface may not exceed **two hundred thirty-one thousand US dollars (231.000 USD) - 275 USD/m² x 840 m² -**, VAT excluded.

Any quotation exceeding this amount will be dismissed.

This is an estimated cost; if the square meters or elements of the Pavilion vary, it will imply a variation of the cost, according to the price per square meter.

The price per square meter specified in the tender, may not be varied or amended in any way by the Awardee, <u>during the period of the Contract and following extensions</u>, unless express Contract thereon by the Parties.

The price per square meter tendered must include all works regarding the construction, assembly, provision and connections of additional mechanisms and devices necessary to make all the equipment work, even those rented by the exhibitors such as refrigerated displays, audio visuals, etc., maintenance and disassembly of the Spanish Pavilion, as well as all expense items arising from transport from and to the site where the Fair is held, drayage and the necessary equipment for assembling and dismantling the Pavilion, warehousing and transport of loads within the Fair and rental of whatever other services are required within the Fair in order to execute the Agreement.

The price must also include:

- Set up, maintenance and dismantling labours, supervisor labours, Truckage charges, disposal costs, management fees, handling Charges/Drayage or the production and hanging labour (hanging points, installation and dismantling) of all the hanging elements if required.
- <u>Disposal of Waste.</u> The waste from the exhibition, used materials, and all other waste in and around the booth shall be removed by the awardee (Construction and exhibitors waste). The expenses for the disposal work shall be borne by the awardee. This cost will be included in the tender price.
- <u>Electricity and Power supply</u>. All electrical and pipe installations work from source of supply at the exhibition (even if these works must be carried out solely by the Organiser's official contractor). Additional connections and secondary wiring works shall be borne by the Awardee.
- <u>Civil liability insurance</u> that covers any claims filed following personal or property damages
 or losses suffered by workers, exhibitors, visitors, or any other person during, or
 consequently, of the assembly, dressing or dismantling of the Pavilion.

No additional extra costs will be accepted.

The price does not include:

 Sponsorship fee for hanging signs. The amount of the Sponsorship fee charges should be calculated separately, and the tenderer must submit a Sponsorship fee an estimate together with the tender.

The amount of Sponsorship fee <u>should be calculated separately</u>, and the tenderer must submit an estimate, clearly and distinctly specified in the tender bid. <u>The awardee company will be responsible for managing the permits of the sponsorship fee for the hanging signs with the trade fair and ICEX will be the one who sign the contract with the trade fair organization.</u>

FOURTH. - Estimated Contract Value

FIFTH. - Price and payment arrangement

The total price will be paid, following submission of the appropriate invoice, in the terms that ICEX and the Awardee Company agree. ICEX cannot affect payment in advance.

ICEX will satisfy the amount specified in the tender within 30 days after the conclusion of the fair upon presentation of the corresponding invoices, issued in US dollars, once the penalties, if any, have been deducted

In the event that the Tradeshow is not held, or the Pavilion is cancelled, ICEX shall solely satisfy the expenses incurred by the Contractor as from the date of award of this contract (and in connection with the same) until the date of formal notice of this circumstance by ICEX. In order to be reimbursed, the Contractor shall previously submit all documentary invoices of the expenses incurred up to that date. In the same way, the Contractor shall reimburse ICEX the amount advanced of the expenses not incurred.

Please note that any expenditure incurred by candidate Companies in the preparation of the proposals presentation and quotes will be at the expense of those companies involved. Submission of the offer will not generate any fees or reimbursement of any type of expenses.

Submission of an offer and participation in this tender implies the Company express acceptance of all the points contained in this briefing.

The proposal needs to be sent via email to tenders@icex.es by (September 27th) at 14:00 hours Dubai local time. Otherwise, rulings of the bidding process oblige to exclude your entity from continuing in the procedure.

All files should not exceed 4mb in size if sent as attachment; should files be larger, use a file transfer service, which you have verified works.

The proposal will need to be presented in **English or Spanish**, electronically as a pdf and where appropriate, use Excel for numbers.

All competing Companies submitting a proposal should be aware that ICEX Legal Services will review the documentation submitted to ensure that they comply with the requirements of this tender

After verifying compliance with the Company requirements (see Document 1), the technical offer (work proposal see Document 2) will be reviewed and evaluated. Once the evaluation scores have been assigned to the technical proposal, the economic offer and automatic criteria (Document 3) will be opened and evaluated. The price contained in the economic offer will not be known until that moment.

A decision will be made within an estimated period of four (4) weeks from the published proposal due date. The decision will be officially notified via email, to enable the selected agency to begin work promptly.

Proposals not submitted within the deadline will be excluded.

Non-compliance with any of the requirements established in the present briefing will result in the disqualification of the Company concerned.

IMPORTANT: Proposal submission must be divided into three (3) separate documents with their annexes detailed as follows:

The Tenders shall provide detailed information about their companies with reference to the following items:

- All competing bidders will be required to provide a solvency report in order to proof that the
 annual volume of business in United Arab Emirates, referred to the best exercise within the
 last three (3) available depending on the dates of constitution or start of activities of the
 bidder and submission of offers, is equal to or greater than USD 346.500, VAT excluded.
- Mention of other dressing projects in United Arab Emirates in which they have been involved in the last three (3) years, with special stress on dressing projects for National Pavilion at Trade Fairs equal to or greater amount than USD 161.700, VAT excluded.
- As well as a <u>Letter of acceptance signed</u> by a legal representative of the company whereby, they accept each and every term and condition set out in this Call for a Dressing Tender and its Bidding Specifications.

Documentation to be submitted by the bidders:

The offer must necessarily include:

- Plans of the proposal, including ground plans, elevations with dimensions, and overall perspectives to show a proper comprehension of the project.
- A sufficient number of layouts and views to show a proper comprehension of the project, prepared by the tenderers.
- Project specifications, including finishes, materials and construction processes. These specifications must take into consideration the aspects indicated in the "Specifications of Works".
- Construction details of all the main elements of the project, with sections, front views and
 perspectives that allow a clearly understanding of the proposed solutions: overhead light
 boxes, showcases, cornice, construction system in shelves (fitting wall system and
 cables), platform and walls.
- Specifications and details of the booths & overhead's structure lighting. Specifications and technical details, including luxes and temperature of light data, design, and type of the luminaires, colour and adjustability of the spotlights. Layout with the proposed position of the luminaires.
- Perspectives and/or 3D computer graphics to show a proper comprehension of the project.
- Photographs of the materials and construction systems proposed.
- Pictures and description of the furniture, audiovisuals and lighting fixtures proposed.
- Details and information concerning Improvements.
- Specifications of the Environmental proposed project.

The formats indicated above are mandatory.

The information provide in Document 2 does not clash with the information required in Document 3. The tenderer must avoid introducing in Document 2 any reference with the prices.

NINETH. - Extension of the contract

In order to uphold the institutional image of Spain at International Trade Shows or Fairs, ICEX hereby reserves the right to extend the Contract signed with the Awardee for the following of the followings two (2) editions of the Trade Fair regardless the date of execution without convening a new tender. The general terms and conditions of the Bidding Specifications governing this Tender shall apply to the extension.

TENTH. - Modification of the contract

Once the contract has been formalized, the modifications considered necessary for its correct execution may be agreed, as long as they do not alter the global nature of the initial contract or

imply a substantial modification. For these purposes, those whose cost implies a variation in the contract price of more than 20% will be considered a substantial modification.

Possible changes in the contract price may be due to a change in the fair location or to new functionalities in the program of needs and /or equipment of the institutional stand or company stands, the inclusion of elements that reinforce the signage at height, which it may be necessary to introduce in this or the next editions of this fair if the contract is extended.

In this case, the successful tenderer will provide in writing, at the request of ICEX, the technical, economic and other conditions, before carrying out any modification to the contract. The modification must be previously approved by ICEX and formalized in the corresponding contract.

ELEVENTH. - Force Majeure or restrictions imposed by the Fair Ground Authorities

The parties will not be responsible for the damages and losses caused to the other party for delays or breaches of this Contract that bring their cause in cases of *force majeure* or restrictions imposed by the Fair Ground Authorities. The duties of this Contract will be considered suspended while the situation of *force majeure* or trade fair restriction lasts, and the parties will try to reach an agreement in good faith that benefits their respective interests as much as possible. In any case, the party that has knowledge of these facts must inform the other as soon as possible so that said duties are suspended or that the measures deemed appropriate are adopted. If the cause of *Force Majeure* or trade fair restriction extends in time until 2025, either party will be entitled to request the termination of the contract without having to indemnify the other party for it

TWELFTH. - Cancellation or postponement of the fair

In the event that the Tradeshow is not held in 2025 or 2026, or the Pavilion is cancelled in 2025 and 2026, ICEX shall solely satisfy the expenses incurred by the Contractor or the awardee as from the date of award of the contract (and in connection with the same) until the date of formal notice of this circumstance by ICEX. In order to be reimbursed, the awardee shall previously submit all documentary invoices of the expenses incurred up to that date. In the same way, the Contractor shall reimburse ICEX the amount advanced of the expenses not incurred.

THIRTEENTH. - Execution of the Contract

ICEX Project Manager is ultimately responsible for setting up the Pavilion. In the absence thereof, the Coordinator or Manager of the Spanish Pavilion will have ultimate responsibility. Any specific requests made by the exhibiting companies shall be responded to after consulting Project Management. The successful bidder shall not, under any circumstances, respond directly to oral requests, which must be addressed to: dubai@comercio.mineco.es

All construction, assembly and dressing work, in connection with the Pavilion, must be completed twenty-four (24) hours before each of the Trade Fair Opening at latest except in the event of force majeure or restrictions imposed by the Fairground Authorities. The last day of such works shall be devoted to cleaning tasks in general and attention to stands. The Pavilion must be completely clean one (1) hour before the Trade Fair opening of each fair.

All works must be conducted pursuant to the technical specifications set out in these bidding specifications (Section – Technical Specifications B) and with adequate materials/furniture and finish, whereby faulty or low-quality materials shall not be acceptable.

The Awardee is likewise obliged to dismantle the stands within the term and provisions contemplated in the Regulations of the Enclosure, as well to the instructions given by ICEX or its representatives at the Trade Fair.

FOURTEENTH. - Obligations of the Contractor

The Contractor shall be responsible for compliance of all technical regulations established by the Trade Fair Regulations, and to submit them layouts needed for approval as well as for the payment of the deposits asked by Organisers to allow the works at Exhibition Hall that have to be included in the Tender price.

The Contractor shall avail itself of the necessary human and technical resources in order to meet its obligations. In the event that the Contractor subcontracts any of the works herein assigned to the latter, only the Contractor shall be held liable to ICEX, without recourse to the subcontracting company. Likewise, the provisioning of services and obtaining the necessary permits and authorisations and insurance required to undertake the assembly, dressing and dismantling works concerning the Pavilion shall be fully met by the Contractor. In any event, the Awardee must take out a civil liability insurance which covers any claims filed following personal or property damages or losses suffered by workers, exhibitors, visitors or any other person during, or as a consequence, of the assembly, dressing or dismantling of the Pavilion. All costs arising from these items must be set out in the financial tender submitted.

The Contractor hereby undertakes that throughout the assembly process of the Pavilion, it shall appoint a person vested with sufficient capacity to order the changes which may be required following unforeseen or uncomfortable circumstances during the assembly process.

The Contractor shall likewise provide ICEX with the number of workers required in order to help the exhibitors <u>during the afternoon previous to the Trade Fair inauguration and the morning in which the Trade Fair has been inaugurated and at least two (2) members of its "in-house" personnel to ensure "on-site" proper maintenance of the Pavilion throughout the Tradeshow.</u>

ICEX is entitled to amend or cancel specific items and in that event the Contractor shall be notified of the foregoing sufficiently in advance.

FIFTEENTH. - Subcontracting

The contractor will not be allowed to subcontract any of the works assigned hereof, unless ICEX previous authorization. In that event, exclusively the contractor will be held liable before ICEX for the works or omissions of the subcontracted company.

SIXTEENTH. - Ownership of the designs

All designs used in the Spanish Pavilion are the proprietary ownership of the ICEX, and may not be reproduced, copied or used by the Contractor for any other clients or projects.

SEVENTEENTH. - Health and Safety at Work

The Awardee shall be responsible for compliance of all industrial, health and safety regulations established by the legislation of the country in which the Trade Fair is held and by the Regulations of the Enclosure.

EIGHTTEENTH. - Penalties

18.1 Assembly

ICEX may impose penalties following an inadequate or poor finish, the use of faulty or badly preserved materials, and in general, for any <u>assembly deficiencies</u>. Such penalties shall be reckoned pro rata to the damages caused.

Any <u>delivery delay</u> on the agreed schedule (24 hrs before of the Trade fair Opening) shall entail a 4% penalty on the total amount of the Agreement for each of the first six (6) hours or fraction of an hour, with an additional 10% surcharge from the sixth to the twelfth hour. Should the delay exceed twelve (12) hours, ICEX shall study the appropriate penalty thereon, which in no event shall be more than the result of applying 50% to the total consideration of the Agreement.

In the event that the works are not completed when the opening of the Fair takes place, ICEX may, notwithstanding the penalties foreseen in the foregoing paragraph, claim damages from the Contractor (likewise referred to as the Awardee).

When delay in completion of works is due to any breach of the Trade Fair Regulations, the penalty system abovementioned shall be enforced.

If all the required elements of the stands are not made available to the participants in due time and manner, ICEX is entitled to apply the penalties it deems appropriate, and ICEX reserves the right to lease such elements to third parties.

18.2 Pavilion maintenance and deficiencies during the fair

ICEX may impose penalties if the execution of the Pavilion maintenance work during the duration of the fair is not carried out properly and within a reasonable period of time to guarantee the normal functioning of the Pavilion; The amount will be set in proportion to the damages caused by the delay and/or poor execution of the work, after hearing the contractor and by agreement of the contracting authority.

Likewise, ICEX may establish penalties for damages caused during the days of the fair resulting from the use of inappropriate materials, materials not approved by the fair regulations, due to defects in the installation of constituent parts of the stand, which will also be assessed the implications for ICEX or third parties may arise from omissions, errors, inadequate methods or incorrect conclusions in the execution of the contract. The successful bidder must carry out the correction of defective or incorrect work at his own expense. Penalties will be calculated in proportion to the damages caused, after hearing the contractor and by agreement of the contracting body.

18.3 Dismantling

ICEX may establish penalties in the event of an inadequate dismantling and withdrawal of the elements used in connection with the decoration of the Pavilion, pursuant to the Fair Grounds Regulations thereon pro rata to the damages caused.

Breach of the dismantling schedule as set out in the Fair Grounds Regulations shall entail the application of a penalty to be determined by ICEX which in no event shall be less than 10% of the aggregate consideration for the Contract.

Any <u>dismantling delay</u> on the agreed schedule by the Fair Ground Regulations shall entail a 4% penalty on the total amount of the Agreement for each of the first sixth hour. Should the delay exceed six (6) hours, ICEX shall study the appropriate penalty thereon, which in no event shall be less than 10% of the aggregate consideration for the Contract.

18.4 Non-celebration of the fair

In the event of the Fair is not held, or the Pavilion is cancelled, ICEX will only cover the expenses incurred by the Contractor from the date of communication of the start of the work (and in relation to it) until the date of formal notification of this circumstance by ICEX. To be reimbursed, the Contractor must previously present all invoices or other documentation of expenses incurred up to that date.

NINETEENTH - Termination

This service / activity is eligible for co-financing from the European Regional Development Fund (ERDF).

ICEX is entitled to terminate this Contract following a breach of the Contractor of any of its contractual obligations, in addition to any claim for damages and legal remedies which may be available.

TWENTIETH. - Applicable legislation

Dressing works shall be governed by the terms of the Contract entered into between the awardee Contractor Company and by the tender specifications, which shall be incorporated to the same, and in default of the above, the Spanish legislation shall be applicable.

TWENTY-FIRST - Jurisdiction

In order to solve any dispute, disagreement, issue or claim which may arise from the performance or construction of the Contract executed with the successful Awardee of this tender, the matter will be referred to the ordinary Courts. The parties, renouncing the jurisdiction that may correspond, expressly submit to the Courts of the city of Madrid.

1. NEEDS PROGRAM

The Pavilion of Spain project, which is presented together with this tender as **ANNEX 4**, has the intention to enhance the presence and image of Spain and the Spanish companies, and to serve as a platform for every exhibiting company to freely customize its image inside its own space.

Pavilion of Spain areas:

1.1. Institutional stand of the pavilion of Spain (ICEX BOOTH)

There will be an institutional stand that will be used for providing general information and specialized, industry-specific assistance to professional visitors. It will also be a service area for exhibitors.

As it is the main information area of the Pavilion of Spain, the furniture and all the other decorative items of the Institutional Stand must be of a high quality and design.

The Institutional Stand must show the image of Spain as a country that produces high quality and design. Therefore, it must contain items and materials that the bidder deems appropriate for this purpose.

The design proposed must highlight the Institutional Stand through lighting and any other means considered appropriated by the bidder.

The Institutional Stand will occupy an estimated area of 9 sqm. A tentative layout may be seen on attached plans.

The Institutional Stand will have the following equipment:

- a) An information and visitor assistance counter.
 - A custom made information counter with corporate logos on the front, inner shelves and a lockable area for brochure storage. ICEX logo will be placed on the counter's front. Sockets inside the counter. Backlit front will be positively appreciated.
- b) 2 stools
- c) 1 catalog stand
- d) 1 table
- e) 4 chairs
- f) 1 hook on the counter's side for hanging bags bearing advertising.
- g) 1 wastepaper basket
- h) Graphic element covering the walls' surface.
- i) Lockable low storage cabinets 1m high all along the back wall.
- j) 1 multiple socket with 4 sockets.

1.2. Stand design (COMPANIES BOOTHS)

The stand decoration will be the same for all the exhibiting companies. The design harmonize the image of the companies with the image of the country. Particular value will be placed on how both images combine and on the uniformity of the "Spain" brand in all the stands. It will consist of paneling with a hidden structure so that graphics can be placed all along it continuously.

Fronts or features that might create an obstacle for the access or visibility should be avoided.

The sign containing the identification of each company (name, logo and booth number) will be placed facing the aisle on top of the walls in two places. Optionally the bidder can include a LED stripe inside to light up this element.

The minimum surface area per stand is set at 9 m². The bid must include the following items (this set of items is referred to as "set of furniture" from now on) as supply for each 9 sqmt area:

- a) 1 lockable Glass showcase counter display in beech or light oak finish. The lower side must include lockable storage space with an inner shelf. The quality and design of this counter will be appreciated. In the upper glass display the bidder, <u>optionally can add a LED stripe to light up the exhibitors products on display</u>. Dimensions: 100L x 50D x 100H cm. <u>Backlit front will be positively appreciated</u>.
- b) 1 podium measuring 50x50 and 100cm high.
- c) 1 table (80cm diameter)
- d) 4 chairs

The stand is provided with one set of furniture for each 9 meters of surface or fraction thereof.

 - Shelves inside the storeroom: 3 linear m.

The final number of storerooms will vary depending on the number of exhibitors requesting them.

The Contractor will ensure that all the proposed materials comply with all relevant rules and regulations and that their installation will be permitted by any authority involved, obtaining all necessary permits and certificates as per the "General specifications of works" of this Invitation to Tender.

2. FLOORING

The entire flooring of the Pavilion of Spain will be covered in wood flooring beech or light oak finish. Maximum recommended height: 5cm, if possible.

In order to facilitate the access to disabled visitors, the perimeter of the flooring will have a chamfered edge to provide a slight slope.

The floor material should cover the entire area occupied by the pavilion.

Optionally the bidder can include a red carpet flooring for the adjacent aisles around them, if appropriate and approved by the Fair Organization.

Other kind of flooring that may improve wood flooring, will be positively appreciated.

In order to protect the flooring materials, visqueen or similar cover will have to be installed over them prior to installation of the exhibits. Labour to remove the cover before the opening ceremony must be included in the overall price, as well as labour to remove all floorings after show closes and all relevant labour costs related to the floorings.

A sample/picture and colour options of the proposed flooring material should be included in the bid.

3. WALLS / PANELS

The basic structure of the booths will consist preferably of built-in modules showing no joints and must have resistance enough to hang shelves and TVs.

Walls must have a continuous look, with all frames, poles or other elements of the wall structure totally concealed.

On top of walls there will be a cornice to accommodate the lighting. Preferably linear LED strip light system. Modules should be connected one after the other via plug-in terminals for homogeneous lighting. It is very important to get a bright and powerful illumination on the walls and first level shelves.

The <u>back walls</u> of the booths must be 2,44m high, emerging in certain places up to 4 m (depending on the venues allowance), in order to incorporate the National identification on top of it.

The first and higher area (from 2,44m up to 4,0m high) will consist of light-coloured plywood or natural wood slats and a light box that includes the HEALTH CARE FROM SPAIN logo. The images are attached in Annex 5 – Artwork.

The lightbox inner structure must be hidden so as not to cast shadows over the graphics. The outer material must be tautened so that it appears totally flat, with no creases, folds or rucks. The material must comply with the fire requirements.

The dimensions of the slats may be slightly modified to avoid waste of material or to allow a better offer.

 Downwards, the rest of the space down to the floor (2,44m), may be personalized by each exhibitor. The bidder must include a graphic panel covering all the wall surface for each exhibitor requesting it.

Regarding the <u>side walls</u> separating exhibitor's booths, the height should be no higher than 2,44m. Facing the aisle in each partition between booths there will be an **Identification Display** (from now on ID Displays). It will consist of a double-sided 0,5m x 0,50m element with beech or light oak finish frame, including booth number and exhibitor's logo. <u>Including a LED stripe inside to light up this element will be positively appreciated.</u>

The main walls where exhibitors are allowed to personalize them with posters or graphic elements are white.

The finishing of the backwalls will be prepared for printing out on them, as a whole graphic. If the exhibitor does not require to cover the walls of their booth with images (total or partially) then the finishing of the walls will be built in white colour.

As stated previously, when required by exhibitors, all storage rooms and additional walls inside the booths requested by exhibitors will be built by the contractor at no extra cost. 4. HIGH LEVEL SIGNAGE: IDENTIFICATION OF THE PAVILION OF SPAIN

The companies taking part in this tender process shall provide a detailed proposal of the national identification of the Pavilion of Spain, taking into consideration the following requirements:

The design pretends to highlight the overhead's view of the Spain's national identification reaching the maximum height permitted (6 m) to improve the visibility and identification SPAIN, by using backlit graphics.

All projects submitted must include high-level signposting in English:

- a) From the structure of the trade fair venue's ceiling, using **backlit hanging signs** (from 5m up to 6m high). Particular value will be placed on its design and visibility.
- b) From the structure of the stands themselves. The upper side of the walls (from 2,44m up to 4,0m high) will consist of light-coloured plywood or natural wood slats and a lightbox that includes the HEALTH CARE FROM SPAIN logo. The images are attached in Annex 5 Artwork.

In any event, the successful bidder will bear all the costs of hanging up and placing the structures and will also be responsible for managing the permits with the trade fair.

Regarding the backlit elements (both hanging signs and lightboxes): they must be perfectly lit (LED highly recommended) to get an impressive and highly bright image of all graphics.

Visible joint elements will not be admitted. All corners must be built to minimize the joints and corner pieces. Construction details to be sent by the Tenderer.

Interior frames must be concealed

The awardee will be responsible for printing the images.



The awardee company will create the artworks for this graphics following ICEX instructions and will be responsible for producing of all graphic material as well as the necessary workforce for their correct positioning. The awardee company will submit to Icex the graphics proofs layout for approval before printing all the graphics.

If there were a **sponsorship fee** for the hanging signs, the awardee company will be responsible for managing the permits with the trade fair and will pay for these fee in advance in name of ICEX.

5. GRAPHICS

Exhibitor's Booth's graphics

Fach exhibitor stand will have:

- A commercial printed image mounted on backwalls. The image will be previously

 ensure maximum printing quality of the artwork.
- Logo, preferably backlit, (for the Identification Display and for the glass showcase counter front).

The awardee company will be responsible for coordinating and recollecting the artworks from the exhibitors, in order to work on the final layouts, final prints on the walls, and correct installation of the artworks.

Awardee company will be responsible of the production of all graphic material as well as the necessary workforce for their correct positioning. The awardee company will submit for approval a sample to lcex before printing all the graphics.

The size of the final prints will be conformed and adapted to walls sizes. The awardee company must provide the exhibiting companies with these measurements.

The companies' images will be appropriately illuminated through the LED lights linear systems from the backwall cornice.

ICEX's Booth's graphics

Each exhibitor stand will have:

- A printed image, preferably backlit, mounted on backwalls. The awardee company
 will be responsible for the design, composition and elaboration of the final artwork of
 ICEX and institutional graphics following ICEX instructions. The awardee company will

6. ELECTRICITY AND LIGHTING

6.1. General lighting:

<u>Preferably each island will have a truss structure hung from the venue's ceiling</u> containing the lamps in order to provide the pavilion with general lighting.

The truss structure must be aligned with the perimeter of each island to focus lamps to the interior of each island.

This service / activity is eligible for co-financing from the European Regional Development Fund (ERDF).

The number and distribution of lamps must be proposed by the bidder in order to achieve at least 150 Watts per sqm of lighting in the whole area and have to guarantee a homogeneous lighting.

It must provide a correct way to illuminate the graphics, avoiding shadows casted by the structure.

The successful bidder will bear all the costs of hanging up and placing the truss structures and will also be responsible for managing the permits with the trade fair.

All the lights will have the same colour temperature.

6.2. -Backlit hanging signs (from 5m to 6m):

Double-sided Backlit elements hanging from the venue's ceiling directly or from the truss structure <u>preferably with LED technology</u>.

6.3. - High-level Signage (from 2,44m to 4,0m):

These backlit signage elements must provide a correct way to illuminate the graphics, avoiding shadows casted by the structure, visible seams or wrinkles.

The lightboxes will be backlit <u>preferably with LED technology</u>. Powerful system of lamps required to reach the best brightness of the pieces.

6.4. - Exhibitors' - Company's booth:

On top of walls there will be a cornice to accommodate the lighting. <u>Preferably linear LED strip light system</u>. Modules should be connected one after the other via plug-in terminals for homogeneous lighting. It is very important to get a bright and powerful illumination on the walls.

6.5. - Information area (ICEX booth):

A lighting solution must be provided to illuminate correctly this area and its graphics.

6.6. - Storage rooms:

Some lamps will provide enough light for the interior of the storage rooms.

6.7. -ID displays:

Including a LED stripe inside to light up this element will be positively appreciated.

A solution must be given by the bidder to hide all the electric wires and the light lanes for the general lighting.

The contractor will be in charge of and will be held responsible for the electrical fittings and general supply power orders. All power and electricity costs must be included in the Tender.

The Contractor must calculate the electrical requirements to fit exhibitors' and ICEX electrical and lighting needs.

The Contractor will carry out all works related with power installations (even if these works must be carried out solely by the Organiser's official contractor) starting from the general supply points, all the necessary spotlights, display lighting, general lighting, power points and labour to install, assemble, connect and hang all the lights and all of these must be included in the tendering price. No additional extra costs will be accepted.

The awardee company will be responsible for the installation of both general and more specific lighting, ensuring adequate lighting, avoiding shades and guaranteeing white medium colour Led temperature (between 4000k and 5000k) light.

The Contractor will also carry out all subsequent procedures with the official contractors and coordinate with them.

- Reduction of waste generation
- Reduction of the emission of gases
- Use of eco-labeled products or other equivalent quality marks
- Use of recyclable, reusable or recoverable materials
- Use of materials from recycling processes
- Certification of timber and/or forestry products derived from sustainably managed forests

9. MISCELLANEOUS

Project approval and permits

It will be the responsibility of the contractor to manage and contract with the fair all the necessary permits for the execution of the stand and compliance with the fair regulations both in technical aspects and in safety and fire protection.

If requested, the successful bidder will provide the fair organization with the necessary plans for the understanding and authorization of the project and will pay for the deposits or payments that are requested as a previous step to the authorization of the works to be carried out in the fairgrounds.

Production Phase

The works to be carried out by the successful bidder also include:

- The communication of the project to the exhibitors and its adaptation to their requirements and requesting and checking exhibitors' graphic artworks. These requirements will be small (removing shelves, adding extra furniture, electrical or audiovisual equipment, graphic elements, lighting at extra cost) and in no case will alter the original design of the stand, which must necessarily have the approval of ICEX.

- Adaptation of the stand design according to exhibitors' needs and requests.
- Sending final drawings with stand design and graphics proofs to the exhibitor for approval.
- Composition and elaboration of the final artwork of institutional graphics.

It is mandatory that the winning company designates a person as an ICEX interlocutor who works as a Project Manager coordinating the requirements of the exhibitors, ICEX and fair organizer in the coordination and production phase.

That same person will be the one who travels to the fair to coordinate the assembly of the Pavilion on site.

Failure to include this in the bid may result in disqualification of the bid.

Assembly Phase

It is mandatory that the winning company designates a person as an ICEX interlocutor who works as a Project Manager coordinating the requirements of the exhibitors, ICEX and fair organizer in the build-up and assembly phase.

That same person will be the one who travels to the fair to coordinate the assembly of the Pavilion on site.

Delivery of the Pavilion and Cleaning

The Pavilion must be completely cleaned one hour before the opening of the Trade Fair, being this whole responsibility of the Contractor.

The successful bidder shall also be responsible for compliance of all regulations established by the Trade Fair Regulations regarding any dumpsters needed for the removal of any materials, as well as for the removal of the materials itself after the closing of the Trade Fair. This must be included in the overall price.

The Pavilion willbe delivered to exhibitors 24 hours before the opening. The stands will be delivered completely clean to the exhibitors so that when they arrive they can start placing their products.

The Pavilion will be considered delivered only if the stands and storage rooms are completely clean, not only the floor and furniture but the interior of the glass showcases and the surface of the shelves, so that exhibitors can start placing their product on clean surfaces.

If this is not fulfilled within the specified deadline, the penalties set out in this tender will apply.

The awardee company must have sufficient own staff to carry out this task in advance and must also have cleaning staff in all halls where there are stands for the necessary reviews during the day before the opening and the morning of the opening.

Since the cleaning service at the fair is usually overcrowded the day before and the morning of the opening, the awardee company cannot fully entrust the fair cleaning service with the entire cleaning work. It is essential that the adjudicating decorating company allocates a minimum of 2 people of its own staff so that they are available before the arrival of exhibitors, equipped with the necessary cleaning material, that clean the stands as they are going to be completed, regardless of whether the final work cleaning works are contracted parallel to the cleaning service of the fair.

The stands must be absolutely clean:

- 1. At the time the exhibitor arrives to assemble his product, 24 hrs before the opening, so that he can place it in storagerooms, vitrines and clean shelves.
- 2. After the product is placed, the stands are dirty again due to the dust in suspension, so they must be cleaned again for cleaning on the day of the opening, at least one

hour before the opening time so that exhibitors can give the last touch on clean surfaces

Consequently, a penalty will be applied if the decorating company does not deliver the clean stands (floor, vitrines and furniture) for the placement of samples 24 hours before the opening of the fair.

ICEX is responsible for the cleaning of the Pavilion with fair, the days following the opening of the fair, unless it has been offered as an improvement by the awardee company.

Disassembly

The disassembly, waste management and any other procedures or fees related to the works that are the subject of this competition shall be assumed by the awardee company.

Maintenance

The awardee company undertakes to provide a service of maintenance of the Spain Pavilion during all days of the fair which must be carried out by one or more persons with the capacity to repair any malfunction of any kind that may occur. This staff must be physically present during the fair and be able to communicate in Spanish or English.

The awardee company must build the Spain Pavilion so that any malfunction that may occur can be resolved by the maintenance team that remains at the fair. It is therefore advisable to take into account the conditions of the Spain Pavilion and to study a rationalized construction system that allows the repair of defects within a maximum of 12 hours from the communication of the fault.

Others

Communication language regarding this tender, as well as the execution of the successful project, will only be English or Spanish.

Furthermore, the decorator undertakes to pay any fee arising from performance of work outside hours at the trade fair, and any other fee that the trade fair organization might request, both at the beginning and at the end of the trade fair which are not included in these specifications.


All items relating to the electricity and water supply, drains and compressed air must be hidden and, in passageways, have indicating signs and be protected.

The awardee company will be obliged to comply with all instructions, corrections and modifications given by ICEX, both in the project phase and during the preparation and construction of the Pavilion.

ICEX reserves the right to inspect, control the quality of the finishes and the manufacturing process of all materials to be used in the assembly of the Pavilion as often as it deems necessary. The awardee company shall comply with all the guidelines established by ICEX as a result of these inspections.

The more detailed and defined the offer, the better the evaluation of the technical criteria will be possible. Furthermore, aspects that are not sufficiently explained cannot be evaluated to the fullest extent.
